#### Resident Population and Age

The resident population of Beckton, as measured in the 2001 Census, was 13,112 of which 48 per cent were male and 52 per cent were female. The resident population of Newham was 243,891, of which 49 per cent were male and 51 per cent were female.

There are two main benefits associated with health that are paid to people needing help with personal care. They are the 'Disability Living Allowance' and the 'Attendance Allowance'.

The Disability Living Allowance is a benefit paid to people under 65, who are disabled, and need help with personal care, and/or getting around. In August 2000, 10,155 people in Newham received this benefit.

The Attendance Allowance is paid to people over the age of 65, who are so severely disabled, physically or mentally, that they need supervision or a great deal of help with personal care. In May 2000, 4,240 people in Newham received this benefit.

Within Beckton, 8 per cent of those unemployed were aged 50 and over, 18 per cent had never worked and 31 per cent were long term unemployed.

In August 2000, there were 7,545 Jobseeker Allowance claimants in Newham of which 48 per cent had child dependants. The Job Seeker Allowance (JSA) is payable to people under pensionable age who are available for, and actively seeking, work of at least 40 hours a week. Figures produced here are those only for people claiming income-based JSA.

In August 2000, there were 29,290 Income Support claimants in Newham, of which 2 per cent were aged under 20. Income support was introduced on April 11th 1988 and can be paid to a person who is aged 16 and over, is not working 16 hours or more a week, and has less money coming in than the law says they need to live on.
